Notes:

1. This Gift Aid Declaration must be completed by the same person who makes the membership payment(s) and/or donation(s). By simply completing this Gift Aid Declaration ***and with no further requirement on your part***, you enable TSCC to reclaim tax from the Government on the membership subscriptions that you pay (and any other donations that you may make to TSCC). Under the Gift Aid scheme, your membership subscriptions are treated as Gift Aided donations.
2. You should only complete this Gift Aid Declaration if you are a taxpayer. In each tax year you must pay an amount of income tax and / or capital gains tax at least equal to the total amount of tax that will be reclaimed in that year by TSCC and any other organisations to whom you have made Gift Aided donations. Other taxes such as VAT and Council Tax do not qualify. Currently TSCC is able to reclaim 25p for each £1 that you pay in membership subscriptions.
3. You can cancel this Declaration at any time by notifying the Honorary Treasurer of TSCC.
4. If your circumstances change and you do not in the future pay sufficient tax on your income and / or capital gains to qualify under the Gift Aid scheme, you must cancel your Declaration (see note 2).
5. If you pay tax at the higher rate, by listing all Gift Aided donations on your Self-Assessment tax return you can claim further tax relief for yourself.
